Indications:

The Swiss Therapy Eye Mask was designed as a lightweight, cooling, non-adherent, eye compress to be used postoperatively following any surgical procedure around the eye zone requiring cold therapy.

How to use The Swiss Therapy Eye Mask

- Step 1. Prior to application, the tray containing the masks should be refrigerated for 10-15 minutes. Masks may also be cooled by placing the tray, with the mask, on a bed of crushed ice. **DO NOT FREEZE**
- Step 2. To remove the sterile mask from its tray
 - a. Remove the mask tray from its outer wrapper. Note *the clear plastic sheet* covering the mask in the tray.
 - b. Grasp the plastic sheet **and** the mask's tab.
 - i. Gently pull the sheet/mask, in a parallel direction, removing the mask from its tray
 - ii. Grasping the tab(s) place over the eyes and nose area.
 - iii. Gently separate the sheet from the mask
- Step 3. One mask should be placed over the nose and eye area immediately post-op. A second mask in its tray should be kept cooling next to the patient on a bed of crushed ice. The third Swiss Eye mask should be given to the patient to be used at home.
- Step 4. To provide continuous cooling for the patient, the masks should be rotated every 15-20 minutes. Note: The patient may, at first, experience the sensation that the mask is no longer cooling. This sensation is due to the skin being desensitized by the initial cold.
- Step 5. At home: After each use the mask should be rinsed with a sterile balanced salt solution (contact solution). The mask should then be stored in the refrigerator in their trays, inside a zip lock bag.
 - Each mask is for single patient use.
 - Do not freeze
 - To prevent possible future infection of the eye, masks should not be used beyond the postoperative period suggested by your physician.
